

### Term and Conditions

The Australian Refugee Association (ARA) requests that the Terms and Conditions below be read, understood and agreed to with the submission of the Expression of Interest form. The Expression of Interest (EOI) for the Community Support Program (CSP) informs ARA, as an Approved proposing Organisation (APO), of a person's interest to partake in the program while providing ARA with the relevant information to determine whether the main applicant and Australia supporter meet the required eligibility criteria.

**Prior to lodgement of your EOI, ARA recommends that you attend one of our CSP Information Sessions. This will assist you with understanding all formal requirements for Humanitarian Visa Applicants and Australian Supporters through the CSP.**

The EOI may only be undertaken by an Australian Supporter, without the assistance of a migration agent, who must acknowledge and agree to the following Terms and Conditions.

1. All questions in the EOI must be answered. Failure to answer questions increases ARA's difficulty of assessing your eligibility for the CSP and may make to ineligible.
2. All questions in the EOI must be answered truthfully. Where ARA find that the details provided in the EOI are inaccurate, we will stop processing your EOI and you will not be eligible for the CSP through ARA.
3. Submission of the EOI must be accompanied by a payment of **\$275**. Any EOIs submitted without a payment will not be assessed by ARA.
4. The fee of **\$275** made upon submission of EOI is non-refundable regardless of the success of your EOI.
5. Submission of EOI to ARA does not guarantee your inclusion in the CSP.
6. ARA requires approximately four weeks for the processing and assessment of the EOI from the date of submission. We request that applicants be patient during this period and await confirmation from ARA.
7. ARA will notify all successful applicants within the four week period to arrange an additional assessment appointment for the CSP with a member of the Migration Team.
